



## // *Terms and Conditions*

### **General regulations :**

- Participants must adhere to the competition rules, fee procedures, registration process, submission deadlines and instructions.
- By paying registration fees once, participants are allowed to submit one entry. Participants are required to register and pay registration fee for each additional entry that they wish to submit. The amount of fees depends on the Competition Calendar.
- Participants can register for the competition as individuals or teams from different countries, cities, or universities.
- Prizes are fixed (and inclusive of taxes and banking fees) regardless of the number of members of the team.
- Participants must be the original authors of the submitted content. Participants found to be plagiarising whole or parts of the submission will be disqualified.
- The Jury's verdict is not contestable.
- Participants are not allowed to contact jurors for matters related to the competition.
- Members having business collaborations or blood-relations with the jurors, or the competition are forbidden from participating in the competition.
- Participants must not mention their team ID, team name or names of participants on the materials submitted.
- Participants must not disclose the contents, material, and details of their submissions before the winners are officially announced.
- Violations of the Rules and Regulations are grounds for disqualification from the competition. The registration fees will not be refunded in such circumstances.
- The authorship of each submission is equally attributed to each member of the team.
- The organiser has the right to change dates or other details to improve aspects of the competition. In such an event, participants will be notified withing reasonable time frame.
- Organisers are not responsible for failure to upload submissions before the deadline due to technical difficulties and internet/web malfunctions. It is highly recommended that participants complete registration, payment and submission procedures well in advance of the deadlines. Participants may e-mail the organisers in case of technical difficulties.
- By registering for the competition, participants fully accept all the rules, terms, and conditions of the competition.

### **Submission Terms :**

#### **Treatment of Entries :**

- By taking part in the Competition, participants give the organiser non-exclusive rights to publish and distribute whole or parts of the material in any way, shape, or form and with associated communication as deemed fit and, on any platforms, including online platforms, social media channels and print publications. For all submissions that win a money prize, any intellectual property right and/or industrial right on the project are acquired by the organiser.
- By taking part in this Competition and accepting the Rules and Regulations, Participants declare to be authors of the uploaded Materials. Moreover, Participants declare that the submitted Material comprises new and original works produced by them. The Participants of the Competition guarantee that the submitted Materials do not infringe, in any way, the industrial and intellectual property right of third parties. Participants agree to indemnify and hold the Organizer harmless from any cost or damage connected with the infringement of any third-party intellectual property right.

#### **Rules regarding Rules and Prizes :**

- The dates mentioned by the organisers for publication of the results are to be considered provisional. It is subject to change and dependent on the satisfactory completion of the requisite of the competition.
- Once the results will be published, the organisers reserve the right to verify the identity of the winners. Prizes will be awarded after verifying the identity of the winners and after they sign a self-declaration certifying that they fully accept the terms of the competition and the declaration of the rights regarding the materials.
